U.S.-based Training and Mentoring Program (TMP) for LMIC fellows (LMIC fellow applicants only) LMIC fellows will be required to participate in a one to three-month training and mentoring program at the University of California (UC), usually at the campus where the fellow's primary UC mentor resides. This program will be tailor-made for each fellow's specific needs - incorporating structured learning, skills development (e.g., clinical research, lab research, analysis and scientific writing), networking, and mentoring - to ensure LMIC fellows take full advantage of unique resources at UC. Please develop a draft plan as part of your application with your UC mentor(s) to spend 1-3 months of your yearlong fellowship at their UC campus(es). Of note, once an applicant is accepted to the program it takes GloCal about 5 months to process forms, for a fellow to schedule a visa appointment at the US embassy, etc. Thus, while you will come to the US for orientation around the middle of July, it may not be possible for you to extend your stay in the US to visit UC following orientation, and you may need to return later in the fellowship year to complete this requirement.
